THE INSTRUCTIONS BELOW ARE NOT TO BE PUBLISHED

WHO SHALL FILE:

Every person who regularly transacts business in the state for profit under a fictitious business name shall file a Fictitious Business Name Statement in the office of the County Clerk of the county in which the registrant has his principal place of business, and not later than 40 days from the time he/she commences to transact such business. If the registrant has no place of business in this state, he shall file his fictitious business statement in the office of the County Clerk of Sacramento County (B&P 17910 and 17915).

FAILURE TO FILE:

No person transacting business under a fictitious business name of his/her assignee may maintain any action upon or on account of any contract made, or transaction had, in the fictitious business name in any court of this state until the fictitious business name statement has been executed, filed and published as required by law. (B&P 17918).

NOTICE OF REGISTRANT PURSUANT TO SECTION 17924 BUSINESS & PROFESSIONS CODE

- 1) Your fictitious business name statement must be published within 30 days after the statement has been filed with the county clerk. The statement must be published once a week for four consecutive weeks and an affidavit of publication filed with the county clerk within 30 days after publication has been completed. The statement should be published in a newspaper of general circulation in the county where the principal place of business is located. The statement should be published in such county in a newspaper that circulates in the area where the business is to be conducted. (B&P 17917).
- 2) Any person who executes, files or publishes any fictitious name statement, knowing that such statement is false, in whole or in part, is guilty of a misdemeanor and upon conviction thereof shall be fined not to exceed five hundred dollars (\$500). (B&P 17930).

INSTRUCTION FOR COMPLETION OF STATEMENT

Please Type or Print

- 1) If this is a new business name or a renewal filing, check the appropriate box. If this new statement is required because the current statement has/will expire check this box and enter the file number currently assigned your filed statement on the line provided.
- 2) Insert the fictitious business name, if more than three names are being filed, complete an addendum form.
- 3) If the registrant has a place of business in this state, insert the street address of his principal place of business in this state. If the registrant has no place of business in this state, insert the street address of his principal place of business outside of this state, (PO Boxes are not acceptable).
- 4) If the registrant is an individual, insert his full name and residence address.

If the registrant is a partnership or other association of persons, insert the full name and residence address of each general partner.

If the registrant is a corporation or limited liability company, insert the name of the corporation or organization as set forth in its articles of incorporation or organization, the state of incorporation or organization, and the principal business address (PO Boxes are not acceptable as residence addresses).

- 5) Check box provided whichever of the following best describes the nature of the business "an individual", "a general partnership", "a limited partnership", "a business trust", "a corporation", "an unincorporated association other than a partnership", "co-partners", "husband & wife", "joint venture", "limited liability company", or "other", please specify.
- 6) Complete commencement of business information.
- 7) If the registrant is an individual, the statement shall be signed by the individual.
If the registrant is a partnership or association of other persons, the statement shall be signed by a general partner.
If the registrant is a business trust, the statement shall be signed by a trustee.
If the registrant is a copartner, the statement shall be signed by one of the partners.
If the registrant is a husband or wife, the statement shall be signed by either party.
If the registrant is a joint venture, the statement shall be signed by one of the parties.
- 8) If the registrant is a corporation or limited liability company, the statement shall be signed by an officer. State the title of the officer.

A FICTITIOUS BUSINESS NAME STATEMENT EXPIRES AT THE END OF FIVE YEARS FROM THE DATE WHICH IT WAS FILED, except as provided in Section 17923 of the Business & Professions Code. It expires 40 days after any change in the facts set forth in the statement, except that a change in the residence address of an individual, general partner, or trustee does not cause the statement to expire. (B&P 17920)

REQUIREMENT FOR PUBLICATION

When a new statement is filed because the previous statement has expired under Section 17920 of the Business & Professions Code, it must contain the address of the individual or each partner or trustee as of the date of the new statement and must be republished if there is a change of address (B&P 17920 comment).
NOTE: Refile must be filed within 40 days of the date the previous statement expired in order to avoid republishing.

IF YOU INTEND TO USE THE WORDS "INCORPORATED", INC., "CORPORATION", OR "CORP", THE REGISTRANT MUST BE A CORPORATION. IF YOU INTEND TO USE THE WORDS, "LIMITED LIABILITY COMPANY" (WHETHER USING THE COMPLETE WORDS OR THE ABBREVIATIONS "LTD. AND "CO", OR EITHER OF THEM) OR "LLC" OR "LC" THE REGISTRANT MUST BE A LIMITED LIABILITY COMPANY. THE COUNTY CLERK REQUIRES A COPY OF THE FRONT PAGE OF THE ARTICLES OF INCORPORATION OR ORGANIZATION IN EITHER CASE.
